Idaho Legal Aid Services (ILAS) is seeking applicants for an attorney based in the program's Pocatello Office to serve clients in Bannock, Bear Lake, Caribou, Franklin, Oneida and Power Counties. The office also serves the Fort Hall Indian Reservation and provides legal representation in the Shoshone Bannock Tribal Court. The attorney will represent clients in a variety of areas including family law where there has been domestic violence, housing, guardianships, public entitlements, senior, consumer and Indian law. Ability to speak Spanish a plus.

ILAS is a statewide nonprofit law firm that provides free legal services to low income persons in civil matters. The firm has served Idaho since 1967. Branch offices are located in Coeur d'Alene, Lewiston, Caldwell, Boise, Twin Falls, Pocatello, and Idaho Falls.
